

Subject: Call for applications to the UP Scientific Productivity System (SPS) for CY 2018

The UP System is now calling for applications to the UP Scientific Productivity System for CY 2018.

A. New applications

For new applicants, the period of evaluation of accomplishments is for the last five (5) years from January 2013 - December 2017.

B. Applications for renewal by UP Scientists awarded for the term CY 2015-2017

The period of evaluation of accomplishments is from January 2015 - December 2017 using the points specified in Table 3. Retention/Promotion.

Deserving scientists will be conferred the title "UP Scientist" and will receive a monetary award, the UP Scientific Productivity Award:

UP Scientist I	P 150,000 per annum
UP Scientist II	200,000 per annum
UP Scientist III	250,000 per annum

Please submit your recommendations, properly evaluated by your CU Committees, to our Office on or before **31 March 2018**.

May we request you to submit for each recommendation the following:

- 7 sets of the application form with CU scores, properly endorsed by CU officials
- 3 sets of proof of accomplishments; and
- CD containing the application form (in Word format) and attachments (in jpeg or pdf format).

Please ensure complete documentation for your recommendations. The System Screening Committee shall evaluate recommendations as submitted—no proper documentation, no points credited.
